## 1 Description

Occasionally the values of DELTOCLK in exposure-records files are anomalously high or anomalously low. **Since inaccurate values of DELTOCLK lead to inaccurate pulse heights**, events that are processed using anomalous values have a STATUS bit set to one and are discarded from Level 2 event-data files.

## 2 Input

1. One or more Level 0 event-data file (acis\*evt0.fits) **or a Level 1 event-data file (acis\*evt1.fits)**
2. One or more exposure-records file (acis\*exr0.fits)
3. **An exposure-statistics file (acis\*stat1.fits)**

## 3 Output

1. An **updated** event-data file
2. An **updated** exposure-statistics file

## 4 Parameters

1. infile,f,a,"",,, "Name of input event-data file(s)"
2. outfile,f,a,"",,, "Name of output event-data file"
3. exrfile,f,a,"",,, "Name of input exposure-records file"
4. expstatsfile,f,a,"",,, "Name **of exposure**-statistics file"
5. expnowidth,i,h,5,3,1001, "Number of frames in the sliding time window **(must be odd)**"

6. `minnumframes,i,h,3,3,1001,"Minimum number of frames in window with useful data"`
7. `deltoclkthresh,i,h,3,1,4096,"Minimum offset in adu that is considered anomalous"`

## 5 Processing

1. Verify that the `infile`, `exrfile`, and `expstatsfile` exist. If `clobber=no`, then verify that the `outfile` does not exist. Verify that the values of the parameters `expwidth`, `minnumframes` and `deltoclkthresh` are in the valid ranges for these parameters. Note that `expwidth` must be an odd number.
2. If the data are being reprocessed by a user, then perform the following two steps.
  - (a) Set `STATUS` bit 10 (of 0-31) to zero (i.e. unset it) for all of the events in the `outfile`. Subsequent processing sets this bit to one for the appropriate events.
  - (b) Remove the contents of the HDU “`BADCLK`” in the `expstatsfile`. This HDU is updated appropriately in subsequent processing.
3. Perform the following steps separately for each node of each CCD.
  - (a) For each `valid`<sup>1</sup> frame  $i$ , compute the expected value  $M_i$  of `DELTOCLK`. In most cases,  $M_i$  is the median<sup>2</sup> of the values of `DELTOCLK` for the frames from  $i - w$  to  $i + w$ , `inclusive`, where  $w = (\text{expwidth} - 1)/2$ . There are some cases that require special treatment.
    - i. If the frames range from  $i = 1$  to  $N$ , then for the first frame (i.e. for  $i = 1$ )  $M_1$  is the median value of `DELTOCLK` for the frames from 1 to  $1 + w$ , for the second frame (i.e. for  $i = 2$ )  $M_2$  is the median value of `DELTOCLK` for the frames from 1 to  $2 + w$ , etc.
    - ii. If the frames range from  $i = 1$  to  $N$ , then for the last frame (i.e. for  $i = N$ )  $M_N$  is the median value of `DELTOCLK` for the frames from  $N - w$  to  $N$ , for the second to the last frame (i.e. for  $i = N - 1$ )  $M_{N-1}$  is the median value of `DELTOCLK` for the frames from  $N - 1 - w$  to  $N$ , etc.
    - iii. If one or more frames in the range for which  $M_i$  is being computed is `invalid`<sup>1</sup> and if the total number of valid frames in this range is greater than or equal to `minnumframes`, then perform the computation using the data for the valid frames.
    - iv. If one or more frames in the range for which  $M_i$  is being computed is `invalid`<sup>1</sup> and if the total number of valid frames in this range is less than `minnumframes`, then set  $M_i$  equal to the value of `DELTOCLK` for frame  $i$  (i.e. there is too little data to determine whether the value of `DELTOCLK` is anomalous).
  - (b) If the value of `DELTOCLK` for a frame is greater than or equal to  $M_i + \text{deltoclkthresh}$  or is less than or equal to  $M_i - \text{deltoclkthresh}$ , then
    - i. modify the `outfile` to set `STATUS` bit 10 (of 0-31) to one for all of the events in frame  $i$  for the particular CCD and node in question and
    - ii. update the “`BADCLK`” HDU of the `expstatsfile` to include the `EXPNO`, `CCD_ID`, and `NODE_ID` information for the frame, CCD, and node in question.

<sup>1</sup>Here, a frame is valid if there is `DELTOCLK` data available for it. If no `DELTOCLK` data are available for the frame, then it is considered invalid.

<sup>2</sup>If the number of elements in the set for which the median is being computed is odd, then the median is the middle value of the set after the set has been sorted (e.g. the median of [1,1,1,4,5,6,7] is 4). If the number of elements is even, then the median is the mean of the middle two values of the sorted set. If the mean is not an integer, then the mean is truncated to obtain an integer (e.g. the median of [1,1,1,4,5,6] is 2, not 2.5 or 1).

2. Should there be tests on the absolute values of the overlocks (not just the values of the DELTOCLKs) or should such tests be part of V&V?
3. Add some diagnostic plots (e.g. a histogram of  $\text{DELTOCLK} - M_i$  [for different definitions of the median?], a plot of the fraction of the data that satisfy the `deltoclkthresh` condition as a function of `deltoclkthresh` [separately for each node?], and a plot of the rate at which anomalous values of DELTOCLK occur as a function of time [separately for each node?]).
